As noted on the call, for the first time in Virginia history, **Juneteenth will be an official state holiday**, in recognition of the abolition of slavery and the contribution of African Americans to the Commonwealth and the nation. Governor Ralph Northam today declared this Friday, June 19, 2020, a holiday for state government and promised to support legislation designating a permanent legal holiday that would also cover localities and schools. *DMAS state offices will be closed this Friday, June 19, 2020.*
